



Michiana Echo Soccer Club | Refund/Club Transfer Policy Effective July 26, 2021

Registration: A player registration is a full year commitment to the club (until the next June tryout period) pursuant to Indiana Soccer rules, Echo policy, and the agreement you signed with Echo when you registered. Echo incurs certain opportunity costs and hard costs associated with securing a player's spot on a team and preparing for the player to receive services. The following refund policy is strictly enforced.

General Refund Policy: Subject to the exclusions below, players who register for a Michiana Echo travel team or training opportunity will NOT be granted a refund of any tuition, fees, or expenses (including but not limited to player tuition/fees, uniform costs, training fees, and administrative fees) under any circumstances or for any reason. Michiana Echo reserves the right to retain all associated fees and to charge the payment method on file for any unpaid installments until the entire seasonal year's tuition is paid in full along with any applicable fees or arrearages.

Drop Request: If a player requests to be dropped from his or her team roster following registration, the following refund policy will apply:

Fall Season	Spring Season	Refund Policy
Before August 1	Before January 1	All player fees after subtracting \$100 non-refundable deposit
On or after August 1	On or after January 1	No refund

Any scheduled payments will be cancelled by Echo after the non-refundable amount has been paid. Any excess payment over \$100 will be refunded. ***A drop request DOES NOT release you from your seasonal year commitment to Echo or allow you to play for another club. A release from the club must be separately requested pursuant to the Club Transfer policy.***

Season-Ending Injury Waiver: If a player suffers a season-ending injury as documented by a medical professional, the following refund policy will apply.

Fall Season	Spring Season	Refund Policy
Before September 1	Before March 1	All player fees after subtracting \$100 non-refundable deposit
Before October 1	Before April 1	50% of player fees after subtracting \$100 non-refundable deposit
On or after October 1	On or after April 1	No refund

The club must be notified in writing of the injury prior to the dates specified above. Supporting medical documentation must be provided within a reasonable time of the initial notification. Any player electing to use an injury waiver will not be allowed to return to his or her team during the season for which the waiver is granted unless (a) the player provides supporting medical documentation clearing him or her to participate and (b) all player fees for the entire season are paid in full.

Club transfer policy: It is the policy of Indiana Soccer that a player is committed to one club for the entire club year (from registration after June tryouts until the end of the Spring season the following year). For this reason, players desiring to transfer to another club at any point during the club year **MAY NOT** do so without the express consent of Michiana Echo's Director of Coaching and the Board of Michiana Echo Soccer Club. A request to transfer must be submitted in writing and will be granted only in extraordinary circumstances (e.g. relocation, no team available). To be granted a release, you must pay in full all tuition for the seasonal year (fall and spring) only after all outstanding fees have been paid in full.
